

Notice to Recipient

Pursuant to **Arizona Revised Statutes § 32-1166**, you have been issued a cease and desist order or a cease and desist order and civil citation for violation(s) of **A.R.S. § 32-1151**, Contracting Without a License, and/or **A.R.S. § 32-1165**, Advertising Without a License.

If you received just a cease and desist order and wish to appeal such decision, see the Request a Hearing section below. If you received a cease and desist order and civil citation, you have three possible actions you may take in response: (a) pay the civil penalty assessed by the citation, (b) obtain a contractor's license and pay a potentially reduced civil penalty, or (c) request a hearing to dispute the order. Failure to comply with the provisions of the order may result in further civil or criminal action against you, including, but not limited to, collection activities by the office of the Attorney General of Arizona.

Pay the Civil Penalty:

The civil penalty is payable either in person at the Registrar's office at 1700 West Washington Street, Suite 105, Phoenix, Arizona 85007, or by mail to P.O. Box 6748, Phoenix, Arizona 85005-6748. Mailed payments must be in the form of a cashier's check or money order payable to the Registrar of Contractors. **Do not mail cash**.

Obtain a Contractor's License:

A.R.S. § 32-1166.07 allows the registrar to waive a portion of the civil penalty if the person against whom the civil penalty is assessed completes all of the requirements for, and is issued, a contractor's license. To obtain a license the person must meet all the qualifications for a license (*see* A.R.S. § 32-1122) and remedy any loss or damage caused to the public by the violator's activity. Additionally, pursuant to A.R.S. § 32-1123 the person must not have bid on a project with an aggregate worth of \$20,000 or more within the past year.

Request a Hearing:

The action taken in this matter is an "appealable agency action" pursuant to A.R.S. § 41-1092. You have the right to obtain a hearing by filing a **Request for Hearing**. A Request for Hearing should be sent to the Registrar at P.O. Box 18243, Phoenix, Arizona 85005-8243. The request must be received by the Registrar within 30 days of your receipt of the order. The Request for Hearing must identify the party appealing, the party's address, and a concise statement of the reason(s) for the appeal. The subject of the hearing will be limited to the violation(s) alleged, the scope of the order to cease and desist, and/or the amount of the civil penalty assessed, if any. The Registrar will serve a Notice of Hearing at least 30 days before the hearing, which will inform you of the date, time, and location of the hearing as well as the issue(s) in controversy.

If you file a Request for Hearing, you may also request an Informal Settlement Conference by filing a written request with the Registrar at P.O. Box 18243, Phoenix, Arizona 85005-8243 no later than 20 days before the scheduled hearing. Any statements, either written or oral, made by you at the settlement conference, including any written documents, created or expressed solely for the purpose of settlement negotiations are inadmissible in any subsequent hearing.

Investigator Note: On 12/11/2013, the original documentation labeled evidence 4-7 was received at the ROC office.

On **March 6, 2014**, I drove to in Surprise and met with Ms. Vanchina. I presented her with a photographic lineup to identify Donnie Libby. Ms. Vanchina identified photograph # 5 in the lineup as Donnie Libby. Photograph #5 is the driver's license picture of Donnie Libby obtained from the Arizona Motor Vehicle Division.

Ms. Vanchina explained that she found Libby thru an online referral service, similar to Angie's List. On 08/27/2013, Libby responded to a phone call from Ms. Vanchina. Libby wanted to meet, but Vanchina explained she is still in escrow, and does not have the keys to the two properties. Libby still met with Ms. Vanchina and provided her with a business card (evidence #7) on 08/27/2013. Libby informed Ms. Vanchina that he is licensed.

Libby and Vanchina stayed in contact with one another over emails (evidence #2) until Ms. Vanchina received the keys to the homes. Ms. Vanchina made a sketch of the homes inside showing what she wanted done at the properties and sent it to Libby via email.

On 09/10/2013, Libby again met with Vanchina and introduced a proposal for both properties (evidence #3) for \$4,000. Vanchina explained that Libby added to the cost as the job progressed, via emails. I asked Ms. Vanchina to clarify what work was being done at each of the residences. Ms. Vanchina informed me that following:

| Ms. Vanchina explained that she purchased and lives in the address. This address Libby failed to perform any work, even though she paid Libby for the work. |

Toni Vanchina explained that Libby promised to start immediately, which Libby failed to do. Toni called Libby to discuss the delay. Libby kept explaining he has personal issues and needs more money. Toni explained it was always her initiating calls, and Libby would send most of the calls to voicemail. Eventually on 09/30/13 Toni pays Libby more money to finish the punch list of items to be repaired from the sale of the property.

Libby continues to ask for money to install the faucets in the bathroom. Libby tells Toni he cannot finish the job without the money. Toni explained she had run out of money so she asked her mom (Alice Vanchina) for money to finish the work. Alice Vanchina sends over a check for \$568 to Libby (evidence #5).

Libby promises Toni Vanchina that he will start construction at her residence address). No work ever started.

I made telephone contact with Alice Vanchina while interviewing Toni (daughter). I asked if the check dated 10/01/2013 (evidence #5) was for contracting work, and if her daughter was authorized to make the payment to Libby. Alice Vanchina acknowledged she sent her daughter the check for construction work, and that her daughter was in charge of the contracting job. Alice explained she was not present during the contracts or payments.

On **April 2, 2014**, I attempted to make telephone contact with Libby, with negative results. The voicemail was full, and I was unable to leave a message.

On **April 2, 2014**, Cease and Desist letters for Contracting and Advertising Without a License were issued to Donnie Libby to his last known address located at Surprise, AZ 85379, via certified mail.
