A check of our records determined that Donald E Libby is not licensed with the Arizona Registrar of Contractors and may have contracted with you in violation of Arizona State statutes. It is therefore necessary that I compile certain supporting documents and other material in order to proceed with this investigation. Items of evidence that I will need to present to a prosecutor before he or she will file criminal charges or to issue a civil citation are as follows:

- Copies of any proposals, contracts, or purchase orders relating to your case.
- A copy of both sides of any check(s) paid to the suspect as partial or full payment of your project.
- A copy of any other evidence of payment, such as credit card billings, if applicable.

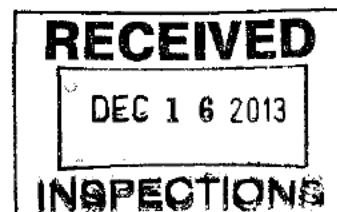
Dear Mr. and Mrs. Libby:

This firm has been retained to send formal demand for interests of Mr. Conrad McGinnis ("McGinnis") with regard to the dispute involving the three properties listed above ("Properties"). Donny and Brenda Libby, DBA Poison Tile ("Poison Tile") was hired by McGinnis on September 7, 2013 to perform various contracting work on the properties. To date the work has not been fully performed and, as a result, not all of the materials paid for have been delivered.

McGinnis paid Poison Tile \$7,000.00 for materials to be used and installed at the properties. Poison Tile began working as agreed, but the work slowly began to diminish. After many deadlines and promises were missed, it was discovered that Poison Tile was not even licensed to do the work contracted. The work was completely abandoned once this was realized leaving two of the listed properties in disrepair. This condition has even caused one of the occupants to move out of the property, which amounts to further money damages.

McGinnis has asked Mr. Libby repeatedly to deliver the materials, which have already been paid for. The following materials have yet to be delivered to McGinnis:

- 11 upper and lower kitchen cabinets (Sollid Brand)
- Granite countertop with Sink (Golden Chocolate)

If the materials above are not delivered within 5 business days of receipt of this letter, McGinnis will seek financial remedy of \$10,000.00 for the materials already paid for, labor, and loss of rental income. Further, he will report Poison Tile to the Arizona State Board of Contractors for performing work on the properties without proper licensing. All legal remedies afforded to him will also be pursued in the event that the materials are not delivered.

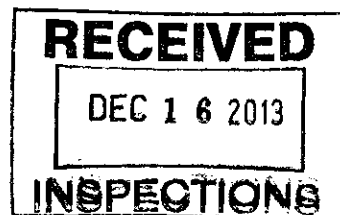

To Whom It May Concern:

I was approached by a person that represented himself to be a licensed contractor, by the name of Donnie Libby DBA Poison Tile, to do work on three of my rental homes. The work on each home was the following:

726 Calle Bolo, Goodyear AZ- Tile Master Bathroom, remove laminate countertop and replace with Granite counter top, and replace dishwasher with new stainless model, purchased through him. And remove and dispose of all old materials.

208 E Loma Linda Blvd, Goodyear AZ- Tile Master Bathroom, remove laminate countertop and replace with Granite counter top, remove old cabinets and replace with new cabinets. Remove and dispose of all old materials

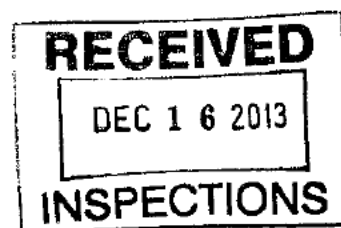
6428 W Hazelwood, Phoenix AZ- Remove and replace old cabinets with new cabinets and remove old laminate countertops and replace with granite countertops. Remove and dispose of all old materials.

Mr. Libby was paid in excess of \$7,000 for this work and was paid by directly depositing funds into two of his personal bank accounts or in cash in person. The work started to lag and miss deadline, for example over 3 weeks to complete a small tile shower.

When I started to get concerned about this delays and the quality of his work, I did follow up with the company that provided the cabinets (SOLLID CABINERY) that Mr. Libby stated he was a distributor, they had no cabinets on order, nor had any record of Mr. Libby ever being associated with them as a authorized distributor.

At that time, I also checked into his license, which I found that he did not have. I then confronted Mr. Libby about this information, which he got upset and never returned to any of the job sites.

Because of this action, he left 2 of the homes is total disrepair, as he had gutted the kitchens and put the debris in the back yard. This forced my renter to move out, as she did not have a functioning kitchen for over 6 weeks.



Mr. Libby doesn't return phone calls, text or emails on this matter. I have sent a demand letter (attached) from an attorney to try to compel Mr. Libby to settle this, but no response. I went to post an ad on Craigslist to warn people about Mr. Libby and found that there are others that he has defrauded in the very same way. I placed an ad and found 3 other people that Mr. Libby has defrauded. The names and contact information of those are listed below. These people have advised me that they also have filed a complaint form with AZROC.

I have and can provide pictures of all of the properties; both before and after Mr. Libby abandoned the jobsite. And also provide video from security cameras inside the home of him working and receiving cash payments.

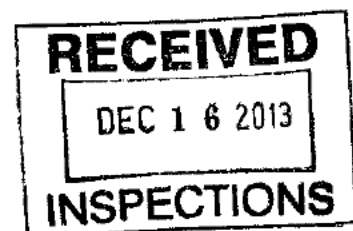

Notice to Recipient

Pursuant to **Arizona Revised Statutes § 32-1166**, you have been issued a cease and desist order or a cease and desist order and civil citation for violation(s) of **A.R.S. § 32-1151**, Contracting Without a License, and/or **A.R.S. § 32-1165**, Advertising Without a License.

If you received just a cease and desist order and wish to appeal such decision, see the Request a Hearing section below. If you received a cease and desist order and civil citation, you have three possible actions you may take in response: (a) pay the civil penalty assessed by the citation, (b) obtain a contractor's license and pay a potentially reduced civil penalty, or (c) request a hearing to dispute the order. Failure to comply with the provisions of the order may result in further civil or criminal action against you, including, but not limited to, collection activities by the office of the Attorney General of Arizona.

Pay the Civil Penalty:

The civil penalty is payable either in person at the Registrar's office at 1700 West Washington Street, Suite 105, Phoenix, Arizona 85007, or by mail to P.O. Box 6748, Phoenix, Arizona 85005-6748. Mailed payments must be in the form of a cashier's check or money order payable to the Registrar of Contractors. **Do not mail cash.**

Obtain a Contractor's License:

A.R.S. § 32-1166.07 allows the registrar to waive a portion of the civil penalty if the person against whom the civil penalty is assessed completes all of the requirements for, and is issued, a contractor's license. To obtain a license the person must meet all the qualifications for a license (*see* A.R.S. § 32-1122) and remedy any loss or damage caused to the public by the violator's activity. Additionally, pursuant to A.R.S. § 32-1123 the person must not have bid on a project with an aggregate worth of \$20,000 or more within the past year.

Request a Hearing:

The action taken in this matter is an "appealable agency action" pursuant to A.R.S. § 41-1092. You have the right to obtain a hearing by filing a **Request for Hearing**. A Request for Hearing should be sent to the Registrar at P.O. Box 18243, Phoenix, Arizona 85005-8243. The request must be received by the Registrar within 30 days of your receipt of the order. The Request for Hearing must identify the party appealing, the party's address, and a concise statement of the reason(s) for the appeal. The subject of the hearing will be limited to the violation(s) alleged, the scope of the order to cease and desist, and/or the amount of the civil penalty assessed, if any. The Registrar will serve a Notice of Hearing at least 30 days before the hearing, which will inform you of the date, time, and location of the hearing as well as the issue(s) in controversy.

If you file a Request for Hearing, you may also request an Informal Settlement Conference by filing a written request with the Registrar at P.O. Box 18243, Phoenix, Arizona 85005-8243 no later than 20 days before the scheduled hearing. Any statements, either written or oral, made by you at the settlement conference, including any written documents, created or expressed solely for the purpose of settlement negotiations are inadmissible in any subsequent hearing.
